Perkins, President, 801 42nd Street South, Bettendorf, IA 52722, under Roll Call No. 18-1043, of June 11, 2018, and the City of Des Moines, and recommending the acceptance thereof, be and the same is hereby approved, and accepted, and

BE IT FURTHER RESOLVED: That \$209,113.53 is the total cost, of which \$163,036.44 has been paid the Contractor, and \$39,803.68 is now due and is hereby approved as final partial payment for the above project, the remaining balance of \$6,273.41 is to be paid at the end of thirty days, with funds retained for unresolved claims on file in accordance with Iowa Code Chapter 573.

BE IT FURTHER RESOLVED: That the Des Moines Finance Director be and is hereby authorized to release said retainage if suit is not filed as above provided.
