## RESOLUTION TO APPROVE AN ECONOMIC DEVELOPMENT GRANT TO THE GREATER DES MOINES PARTNERSHIP IN THE AMOUNT OF \$40,000 TO ASSIST THE PROPOSED LOCATION AND DEVELOPMENT OF A DOWNTOWN YEAR-AROUND FARMERS MARKET

WHEREAS, the Greater Des Moines Partnership is in the process of forming a nonprofit corporation and has initiated preliminary work for the location and development of a year-around downtown farmers market; and

WHEREAS, the Greater Des Moines Partnership has requested assistance with its efforts to identify, secure and perform due diligence on an appropriate site for the development of a year-around downtown farmers market which could include use of the former Central Fire Station No. 1 at 900 Mulberry Street and the City Manager recommends that the City provide assistance in the form of an economic development grant in the amount of \$40,000; and

WHEREAS, the economic development grant to the Greater Des Moines Partnership in the furtherance of the location and development of a year-around downtown farmers market will further the public purposes of Iowa Code Chapter 15A to provide a positive economic impact on the City by enhancing the quality of life within the City and by contributing to the City's efforts to retain and attract a skilled workforce and promote economic growth; and

WHEREAS, the economic development grant assistance to the Greater Des Moines Partnership for the purposes of the location and development of a year-around downtown farmers market will generate public gains and benefits for economic development which gains and benefits are warranted in the comparison with the amount of such assistance.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the City Council hereby authorizes the City Manager to execute a grant agreement in form prepared by the Legal Department for an economic development grant payment in the amount of \$40,000 to the Greater Des Moines Partnership for use in assisting Partnership efforts to identify, secure and perform due diligence for an appropriate site of the year-around downtown farmers market and the Finance Director is directed to make payment in accordance with the grant agreement.
