APPROVAL OF DONATION AND CONSTRUCTION AGREEMENT BETWEEN  
 REBUILDING TOGETHER GREATER DES MOINES, INC. D/B/A REBUILDING TOGETHER AND  
 CITY OF DES MOINES REGARDING ASHBY PARK PLAYGROUND

WHEREAS, the City of Des Moines, acting through the Parks and Recreation Department, operates Ashby Park; and

WHEREAS, Rebuilding Together Greater Des Moines, Inc., d/b/a Rebuilding Together, has proposed donating to the City new playground equipment and installing such playground equipment and materials provided by the City at Ashby Park on October 10, 2019; and

WHEREAS, the Parks and Recreation Department has approved such playground equipment and has agreed that the City shall provide a survey and grading, playground drainage and surfacing, footings for the equipment, site furnishings plants and an accessible ramp, and the Director of Parks and Recreation will accept such improvements on behalf of the City upon their completion; and

WHEREAS, it is in the best interests of the City to enter into an agreement with Rebuilding Together to provide for the donation and installation of such playground equipment and improvements in Ashby Park.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the agreement with Rebuilding Together Greater Des Moines, Inc., d/b/a Rebuilding Together Regarding Ashby Park Improvements, a copy of which is available in the City Clerk's Office, in which the playground equipment and above described improvements in Ashby Park will be paid for and installed by Rebuilding Together and its volunteers through a donation from Meredith corporation Foundation is hereby approved and the Mayor is authorized and directed to sign the agreement on behalf of the City and the City Clerk is authorized and directed to attest to his signature.
