APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, SOUTHWOODS ESTATES PLATI, BETWEEN CONCRETE TECHNOLOGIES, INC. AND TK DEVELOPMENT, L.L.C.

WHEREAS, on August 19, 2019 under Roll Call No. 19-1300, the City Council approved a private construction contract in the amount of \$112,950.00, between Concrete Technologies, Inc., Brad Baumler, President, 1001 SE 37th Street, Grimes, IA, 50111 - as Contractor, and TK Development, L.L.C., Dan Kruse, Owner, 9550 Hickman Rd, Suite 101, Clive, IA, 50325 - as Owner, for construction of Paving Improvements described as paving improvements to service Southwoods Estates Plat 1, a planned unit development consisting of thirteen residential lots, as shown on Plan File Numbers 584-01/08, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$112,950.00, which have been constructed in substantial compliance with the contract documents between Concrete Technologies, Inc. and TK Development, L.L.C., which were approved under Roll Call No. 19-1300, dated August 19, 2019, be received and filed; and that completion of said Paving Improvements described as paving improvements to service Southwoods Estates Plat 1, a planned unit development consisting of thirteen residential lots, as shown on Plan File Numbers 584-01/08, is hereby acknowledged and that said Paving Improvements are hereby accepted.
