APPROVING MEMORANDUM OF AGREEMENT WITH IOWA HOMELAND SECURITY AND EMERGENCY MANAGEMENT DEPARTMENT (IHSEMD) FOR CONSENT TO IHSEMD TO RETAIN CYBERSECURITY RISK REDUCTION GRANT FUNDING FOR USE BY STATE OFFICE OF CHIEF INFORMATION OFFICER (OCIO)

WHEREAS, the U.S. Department of Homeland Security allocates funds to states and local governments through the federal Homeland Security Grant Program for approved initiatives supporting national priorities and state strategies directed toward prevention, response, mitigation and recovery efforts related to terrorist attacks; and

WHEREAS, under the State Homeland Security Program, the Iowa Homeland Security and Emergency Management Department (IHSEMD) may retain grant funds for expenditure by the State of Iowa with the Local Organization's written consent; and

WHEREAS, the IHSEMD desires to award a \$655,000 Cybersecurity Risk Reduction grant to the Iowa Office of the Chief Information Officer (OCIO) and IHSEMD has prepared a Memorandum of Agreement (MOA) in which the City consents to such award as the Local Organization and to the HSEMD retaining more than 20% of the grant funds for expenditure by the State of Iowa on behalf of local units of government; and

WHEREAS, the City Information Technology Department has determined that approval of such MOA is in the best interests of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines Iowa that the above described Memorandum of Agreement between Iowa Department of Homeland Emergency Management and City of Des Moines, Iowa, a copy of which is in the City Clerk's Office, is hereby approved and the Mayor is hereby authorized and directed to execute said MOA on behalf of the City.
