PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 519 FOSTER DRIVE LANDSLIDE ROADWAY REPAIR; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS S. M. HENTGES & SONS INC., STEVEN M. HENTGES, PRESIDENT, \$924,500.25

WHEREAS, on September 9, 2019, under Roll Call No. 19-1368, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the Acting City Clerk, for the construction of the following improvement:

519 Foster Drive Landslide Roadway Repair, 06-2019-023

The improvement includes clearing and grubbing, excavation, soldier beam and lagging retaining wall, grading, rip rap, 18-inch and 24-inch Reinforced Concrete Pipe (RCP) storm sewers, storm intakes, turf reinforcement mat, pavements, guard rail, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 612-060/075, located at 519 Foster Drive, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.




