WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase and installation of equipment on sixteen (16) heavy duty truck chassis for use by Street Maintenance, Street Cleaning, Sewers, Private Property Cleanup, and Forestry Divisions of the Department of Public Works and the Parks and Recreation Department which were approved by the Fleet Oversight Committee (FOC); and

WHEREAS, the equipment on sixteen (16) heavy duty truck chassis is being procured through the competitive bid process utilizing the Sourcewell Cooperative Purchasing Contract #080818-HPI; and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, equipment on sixteen (16) heavy duty truck chassis are being purchased from Henderson Products Inc., 916 South 10th Street, Manchester, IA 52057 (John Sievert, President) in the amount of \$1,242,661 using Sourcewell Cooperative Purchasing Contract #080818-HPI; and

WHEREAS, funding is available from I201, Operating Budget, Equipment Replacement for a total amount of \$1,242,661.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase and installation of sixteen (16) heavy duty truck chassis from Henderson Products Inc. in the total amount of \$1,242,661 using Sourcewell Cooperative Purchasing Contract #080818-HPI.
