WHEREAS, the Information Technology (IT) Department has requested the Finance Department's Procurement Division issue a purchase order for Hewlett Packard Enterprise (HPE) Nimble HF 40 mass storage array and HPE StoreOnce backup storage expansion that will support the City's current and future storage performance and capacity needs; and

WHEREAS, the Hewlett Packard mass storage array and backup storage is being procured through the competitive bid process using NASPO VP - HPE MNNVP-134, State of Iowa Master Agreement 005 16054C; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the purchase of the Hewlett Packard mass storage array and backup storage expansion for the Information Technology (IT) Department is being purchased from OneNeck IT Solutions, 11191 Aurora Avenue, Urbandale, IA 50322, (Terry Swanson, President/CEO) per NASPO VP - HPE MNNVP-134, State of Iowa Master Agreement 005 16054C; and

WHEREAS, funding is available in Capital Improvements Program (CIP) 2019-20/2024-25, Miscellaneous Improvements – page 7, Information Technology, Equipment - New, MS001, C051IT99 for a total amount of \$416,067.91.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase for Hewlett Packard Enterprise (HPE) Nimble HF 40 mass storage array and HPE StoreOnce backup storage expansion from OneNeck IT Solutions in the total amount of \$416,067.91 using pricing under per NASPO VP - HPE MNNVP-134, State of Iowa Master Agreement 005 16054C.
