WHEREAS, the City of Des Moines is a full member of the Des Moines Area Metropolitan Planning Organization (MPO); and

WHEREAS, the Federal Surface Transportation Block Grant (STBG) Program and the Federal Surface Transportation Block Grant Set Aside Fund, also known as the Transportation Alternatives Program (TAP), provides funding to local jurisdictions for the construction of eligible projects; and also

WHEREAS, the programs are administered by the Des Moines Area MPO that prioritizes and ranks all project applications;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the City Manager is hereby authorized to submit applications to the Metropolitan Planning Organization for Federal Surface Transportation Block Grant (STBG) and Transportation Alternative Program (TAP) funds for the following projects.

**STBG Project Applications**

1. Southeast Connector
2. Fleur Drive Bridge over the Raccoon River
3. Intelligent Transportation Systems Upgrade (Maintain/Optimization)
4. Grand Avenue – Martin Luther King Parkway to 28th Street (Maintain/Optimization)

**TAP Project Applications**

1. Central Place Levee Trail, Phase 1
