WHEREAS, on September 10, 2018 under Roll Call No. 18-1486, the City Council approved a private construction contract in the amount of \$34,000.00, between Gator Excavating, Inc. dba Absolute Infrastructure, Kevin Henter, President, 3100 S.E. Mische Drive, Grimes, IA, 50111 - as Contractor, and Hy-Vee, Inc., 5820 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements located at 5801 Hickman Road, as shown on Plan File Numbers 597-231/232, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


