APPROVING COMPLETION AND ACCEPTANCE OF THE
TRAFFIC SIGNAL IMPROVEMENTS SET FORTH IN AND CONSTRUCTED
PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, 1310 25TH STREET,
BETWEEN BAKER ELECTRIC, INC. AND DRAKE UNIVERSITY

WHEREAS, on September 10, 2018 under Roll Call No. 18-1484, the City Council approved a private construction contract in the amount of \$7,825.40, between Baker Electric, Inc., Britt Baker, CEO, 111 Jackson Avenue, Des Moines, IA, 50315 - as Contractor, and Drake University, Victoria Payseur, Vice President for Business & Finance, 2507 University Avenue, Des Moines, IA, 50311 - as Owner, for construction of Traffic Signal Improvements described as traffic signal pedestrian pole relocation on the southwest corner of 25th Street and Forest Avenue including installation of a new footing, hand hole, and wiring to the new location approximately five feet away from the present location, as shown on Plan File Nos. 596-231/235, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Traffic Signal Improvements in the amount of \$7,825.00, which have been constructed in substantial compliance with the contract documents between Baker Electric, Inc. and Drake University, which were approved under Roll Call No. 18-1484, dated September 10, 2018, be received and filed; and that completion of said Traffic Signal Improvements described as traffic signal pedestrian pole relocation on the southwest corner of 25th Street and Forest Avenue including installation of a new footing, hand hole, and wiring to the new location approximately five feet away from the present location, as shown on Plan File Nos. 596-231/235, is hereby acknowledged and that said Traffic Signal Improvements are hereby accepted.
