RESOLUTION ACCEPTING WARRANTY DEED FOR EAST VINE STREET BETWEEN EAST 6TH STREET AND EAST 7TH STREET AND REDEDICATING FOR RIGHT-OF-WAY PURPOSES

WHEREAS, on July 23, 2001, by Roll Call No. 01-2310, the City Council of the City of Des Moines passed Ordinance No. 13,974 vacating East Vine Street right-of-way between East 6th Street and East 7th Street (hereinafter "Property"); and

WHEREAS, the Property was subsequently sold multiple times; and

WHEREAS, Rowat Lofts, LLC is the current owner of the Property and has reconstructed the Property as a street as part of the redevelopment of an adjoining property; and

WHEREAS, on December 16, 2019, by Roll Call No. 19-1989, the City Council of the City of Des Moines accepted the improvements made to the Property pursuant to a private construction contract; and

WHEREAS, the previously vacated East Vine Street right-of-way between East 6th Street and East 7th Street is now needed for roadway and pedestrian way purposes and requires the City to accept of a Warranty Deed from Rowat Lofts, LLC at no cost for the Property and rededication of the Property as public right-of-way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. The Warranty Deed from Rowat Lofts, LLC to the City at no cost for the Property be and is hereby approved and accepted.
- 2. Previously vacated East Vine Street between East 6th Street and East 7th Street, legally described as follows, is hereby rededicated as public right-of-way.
