BETWEEN MCANINCH CORPORATION AND SW7 FLATS, LLC

WHEREAS, on June 24, 2019 under Roll Call No. 19-0967, the City Council approved a private construction contract in the amount of \$13,700.00, between McAninch Corporation, Douglas D. McAninch, President/CEO, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and SW7 Flats, LLC, 6900 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements to serve the Edison Residential Building located at 400 S.W. 7th Street, as shown on Plan File Numbers 611-033/035, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
