University Avenue, Des Moines, IA, 50327 - as Contractor, and Miesblock Commercial LLC, 3101 Ingersoll Avenue, Suite 103, Des Moines, IA, 50312 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements at 665 Grand Avenue, as shown on Plan File Numbers 576-137/138, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
