APPROVAL OF GRANT OF \$40,000 TO POLK COUNTY, IOWA FOR THE IMPLEMENTATION OF A WELCOMING CENTER FOR FOREIGN-BORN POPULATIONS IN THE GREATER DES MOINES AREA

WHEREAS, greater Des Moines has a long history of welcoming immigrants and refugees from throughout the world and such foreign-born population has grown substantially in the last decade; and

WHEREAS, the substantial growth of foreign-born population in greater Des Moines has been the result of opportunities for a better quality of life and economic growth as well as availability of services to individuals and families; and

WHEREAS, foreign-born populations have experienced challenges in accessing services and navigating complex service systems and a report commissioned by the City of Des Moines, Greater Des Moines Partnership and Polk County has recommended the creation of a welcoming center for the foreign-born in greater Des Moines; and

WHEREAS, the welcoming center will provide basic functions for the foreign-born population including serving as an information source on services available to the foreign-born, assisting the foreign-born in navigating service systems and institutions needed to survive and thrive, making referrals to area services and service providers, conducting needs assessments and providing of immediate services to the foreign-born, hosting basic services such as English as a second language classes and other educational opportunities, providing community space for ethnic community gatherings, celebrations and festivals, and providing office space for services related to assisting the foreign-born.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the Council determines that the welcoming center for the foreign-born population in greater Des Moines will preserve and improve the peace, safety, health, welfare, comfort and convenience of the residents of the City.
