PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, GRAY'S STATION PLAT I
BETWEEN MCANINCH CORPORATION AND GRAYS STATION I, LLC

WHEREAS, on August 20, 2018 under Roll Call No. 18-1387, the City Council approved a private construction contract in the amount of \$39,850.00, between McAninch Corporation, Douglas D. McAninch, President/CEO, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and Gray's Station I, LLC, Rick Tolackson, President, 6900 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Sanitary Sewer Improvements described as sanitary sewer improvements to serve 210 S.W. 11th Street, as shown on Plan File Numbers 597-233/234, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Sanitary Sewer Improvements in the amount of \$39,850.00, which have been constructed in substantial compliance with the contract documents between McAninch Corporation and Gray's Station I, LLC, which were approved under Roll Call No. 18-1387, dated August 20, 2018, be received and filed; and that completion of said Sanitary Sewer Improvements described as sanitary sewer improvements to serve 210 S.W. 11th Street, as shown on Plan File Numbers 597-233/234, is hereby acknowledged and that said Sanitary Sewer Improvements are hereby accepted.


