APPROVING RECOMMENDATION FROM COUNCIL MEMBER  
WESTERGAARD TO APPOINT TIFFANY ALLISON TO THE HISTORIC  
PRESERVATION COMMISSION FOR THE THREE-YEAR TERM  
ENDING OCTOBER 18, 2022.

WHEREAS, Council Member Linda Westergaard has recommended that Tiffany Allison be appointed to Seat 8 on the Historic Preservation Commission, which is one of six at-large seats on the Commission, for the remainder of the term ending on October 18, 2019; and,

WHEREAS, Section 58-30 of the Des Moines Municipal Code, as amended on this date, establishes the following qualification requirements for appointment to the Historic Preservation Commission:

The commission shall consist of six at large members and two residents from each designated historic district. **At the time of their appointment, each member shall have a demonstrated interest in historic preservation, and at least four of the at large members shall have at least one of the following professional qualifications** by education, training and experience: architect, landscape architect, urban planner, structural or civil engineer, historian, architectural historian, sociologist, archeologist, real estate broker, real estate attorney or builder. No appointment of an at-large member shall be effective if it results in the appointment of a third at large member without the required professional qualifications.

WHEREAS, all the current at-large members of the Historic Preservation Commission have the required professional qualifications identified above, which allows the appointment of two additional members without the required professional qualifications.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council hereby finds that Tiffany Allison has a demonstrated interest in historic preservation.
2. Tiffany Allison is hereby appointed to Seat 8 on the Historic Preservation Commission for the remainder of the four year term expiring on October 18, 2022.
