PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON RIVERWALK IMPROVEMENTS - PAVER REPLACEMENT; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS MINER HARDSCAPE, LLC, MATTHEW J. MINER, OWNER, \$538,797.00

WHEREAS, on February 24, 2020, under Roll Call No. 20-0319, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Riverwalk Improvements - Paver Replacement, 04-2019-004

The improvement includes removal and replacement of deteriorated sidewalk concrete unit pavers, limestone pavers, and associated work; all in accordance with the contract documents, located along the Riverwalk between Center Street and Vine Street along the west side of the Des Moines River, Des Moines, Iowa

WHEREAS, the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was originally scheduled by the City Council for April 6, 2020 at 5:00 p.m., and was continued by the City Council by Roll Call No. 20-0585, to April 20, 2020 at 5:00 pm, in the Second Floor Board Room in the Richard A. Clark Municipal Services Center at 1551 East Martin Luther King Jr. Parkway.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.
