**WHEREAS**, on March 23, 2020 by roll call 20-0529 the City Council approved submission of the Consolidated Community Plan; and

WHEREAS, on May 11, 2020 the Polk County Continuum of Care Board approved the funding allocations in the accompanying Council Communication and have submitted them to the City Council for approval of their submission to the U.S. Department of Housing & Urban Development.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that submittal of the above referenced funding allocations, on behalf of the Polk County Iowa Continuum of Care Board, is hereby approved and the City Manager or his designee is hereby directed to submit the funding allocations to HUD and authorized to execute any necessary documents.
