WHEREAS, in order to expedite such naming, the City Council desires to waive the requirements of the City's Policy for Naming of Streets, Facilities and Park Land for the naming of such feature at Riverview Park in honor of Polk County.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the area in front of the Riverview Stage shall be and is hereby named and to be known as the "Polk County Front Row Plaza", effective upon the completion of construction of such stage and area and the City Council's acceptance of such improvements.
