RESOLUTION APPROVING PRELIMINARY TERMS OF AN URBAN RENEWAL ECONOMIC DEVELOPMENT AGREEMENT WITH THE DISTRICT DEVELOPERS, LLC, FOR THE PHASED, MASTER PLANNED REDEVELOPMENT OF 11 BLOCKS OF PROPERTY WITHIN THE MARKET DISTRICT, INCLUDING THE SALE AND REDEVELOPMENT OF CITY-OWNED PROPERTY.

WHEREAS, District Developers, LLC (Paul Hayes, Managing Member, 350 E. Locust Street, Suite 309 Des Moines, IA 50309) (the "Developer"), a consortium consisting of JSC Properties and MidAmerican Energy proposes to develop an 11-block area of property within the Market District that would include a mix of residential, office, hotel, retail and entertainment venues and includes approximately six blocks of property owned by the City; and,

WHEREAS, the Developer proposes to be the master developer for the area and will, in coordination with the City prepare the properties for redevelopment by demolishing the existing buildings, conducting necessary environmental remediation reconstructing some public streets and utilities. In addition, the Developer will coordinate with other developers and to invest in the specific development of individual sites within the area; and,

WHEREAS, the project cost to the Developer for preparing parcels for development is anticipated to exceed \$30,000,000.00; and,

WHEREAS, the Developer will participate in Mid-American Energy's Commercial New Construction Energy Efficiency Program, with individual parcel development agreements determining the percentage of energy performance above the energy code that is feasible for each parcel; and,

WHEREAS, developer proposes to purchase the City-owned real estate as required by Iowa law and at appraised value taking into consideration the costs for demolition and environmental remediation; and,

WHEREAS, the proposed terms are for incentives consisting of project generated tax increment on the building valuations, exclusive of land, of 90% for a 20-year term; and,

WHEREAS, the Developer has provided the Office of Economic Development with a financial analysis of the project, indicating a gap between actual project costs and the project appraisal and seeks a financial assistance package to be provided from project generated tax increment and tax abatement as more specifically described in the accompanying Council Communication.
