WHEREAS, in a letter dated June 5, 2020, MidAmerican Energy Company requested of the City of Des Moines an underground electric easement on City property located at 3226 University Avenue; and

WHEREAS, the City and the public will not be inconvenienced by the conveyance of said Easement to MidAmerican Energy Company.

1. The City Council of the City of Des Moines, Iowa, proposes to grant an underground electric easement to MidAmerican Energy Company across a portion of City property located at 3226 University Avenue, in order to provide upgraded electrical service to the City-owned improvements on the property, more specifically described below, in consideration of the utility service being provided to the City therein:

Legal Description


