APPROVING AMENDMENT AND ADDENDUM FOR RENEWAL OF CONTRACT WITH TRAFFIC AND PARKING CONTROL CO., INC. FOR SCHOOL FLASHER SYSTEM AND PROCUREMENT OF 4G CELLULAR MODEMS

WHEREAS, on September 22, 2014, by Roll Call No. 14-1480, the City Council approved a Contract with Traffic and Parking Control Co., Inc. (TAPCO) in which TAPCO provides a School Flasher System, including installation of equipment, BlinkLink software license, hosting and maintenance/technical support, and cellular modem service for the City: and

WHEREAS, TAPCO has informed the City that the 3G modems provided under the Contract will no longer be supported, requiring the City to procure 4G modems to operate the School Flasher System; and

WHEREAS, the initial term of the Contract was from September 22, 2014 until June 12, 2020, with an option to renew for up to three 3-year renewals upon mutual agreement of the parties; and

WHEREAS, the parties desire to renew the Contract for the software related costs and to purchase 101 4G modems at a cost of \$70,700, to be installed and supported by TAPCO pursuant to the Contract, which includes one year of software related costs at no cost to the City; and

WHEREAS, Municipal Code Section 2-726(d) authorizes the procurement of goods and/or services that are of such a nature that they are the only goods/and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing City needs, materials or equipment to be cost effective without conforming to the competitive procurement requirements of the Procurement Ordinance.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the above described Amendment and Addendum for Renewal with Traffic and Parking Control Co., Inc. for the above described school flasher system and 4G modems, a copy of which is on file in the City Clerk's Office, is hereby approved and the Mayor is hereby authorized and directed to execute such Amendment and Addendum on behalf of the City.
