APPROVING THREE (3) LICENSE AGREEMENTS WITH THE SKYWALK ASSOCIATION TO ALLOW INSTALLATION OF CONDUIT AND FIBER OPTIC CABLE FOR SECURITY CAMERAS IN THE SKYWALK SYSTEM

WHEREAS, The Des Moines Skywalk Association (the "Association") seeks to provide for security cameras in portions of the Skywalk System to provide enhanced security; and

WHEREAS, the system requires the use of certain skywalk bridges owned by the City for running conduit to connect the various cameras and equipment; and

WHEREAS, the Association seeks a license agreement to allow the use of conduit in Skywalk Bridges.; and

WHEREAS, the Skywalk Corridor in the parking lots at 5th and Keo Way and at 4th and Grand Avenue may also be needed for conduit or security cameras or both and the Skywalk Association seeks a license for use of these locations; and,

WHEREAS, the City has negotiated license agreements with the Association for use of the skywalk bridges and the skywalk corridors in the two (2) garages.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. The attached License Agreement (Skywalk Security System) for skywalk bridges is hereby approved and the Mayor is authorized and directed to execute the agreement.
2. The attached License Agreement (Skywalk Security System) for 5th and Keo Way Parking Garage is hereby approved and the Mayor is authorized and directed to execute the agreement.
3. The attached License Agreement (Skywalk Security System) for 4th and Grand Avenue Parking Garage is hereby approved and the Mayor is authorized and directed to execute the agreement.
