APPROVING COMPLETION AND ACCEPTANCE OF THE
STORM SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED
PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, 220 S.E. 6TH STREET,
BETWEEN THE UNDERGROUND COMPANY, LTD. AND 220 SE 6TH STREET PROPERTIES, LLC

WHEREAS, on July 15, 2019 under Roll Call No. 19-1083, the City Council approved a private construction contract in the amount of \$98,991.00, between The Underground Company, Ltd., Duane Burkhardt, President, 12245 Dakota Street, Carlisle, IA, 50047 - as Contractor, and 220 SE 6th Street Properties, LLC, Adam Petersen, CEO, 220 SE 6th Street, Suite 100, Des Moines, IA, 50309 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements to serve E. Elm Street between S.E. 5th and S.E. 6th Street, as shown on Plan File Numbers 576-145/151A, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

Elm Street between S.E. 5th and S.E. 6th Street, as shown on Plan File Numbers 576-145/151A, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.
