ORDERING CONSTRUCTION OF
MACRAE PARK IMPROVEMENTS PHASE 3
AND FIXING A DATE FOR RECEIVING OF BIDS ON APRIL 6, 2021
AND PUBLIC HEARING ON APRIL 19, 2021
ENGINEER'S ESTIMATE IS \$2,700,000.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

MacRae Park Improvements Phase 3, 112019002

The improvement includes clearing & grubbing, pavement removal, grading, earthwork, storm sewer, storm intakes, Hot Mix Asphalt (HMA) pavement, Portland Cement Concrete (PCC) sidewalk, PCC pavement for parking areas, PCC curb & gutter, PCC median, segmental retaining wall, playground equipment, pre-engineered steel truss trail bridge and abutments, precast concrete boardwalk installation, prefabricated shelter installation, miscellaneous amenities, pavement markings, seeding and restoration, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 626-188/284, at MacRae Park, Des Moines, Iowa

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$2,700,000.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be held in the MSC Board Room, 2nd Floor, Municipal Service Center, 1551 E. Martin Luther King Jr. Parkway, Des Moines, Iowa, at 5:00 p.m. on April 19, 2021, which may be held by electronic means to encourage and maintain social distancing to curb the spread of Covid 19 in the community without public access to the meeting location, at which time this Council will consider any objections offered thereto or to the making of said improvement.

BE IT FURTHER RESOLVED: That proposals will be received by the City of Des Moines, at the office of the Des Moines City Clerk until 11:00 a.m. on April 6, 2021, for the construction of said improvement, and the taking of bids in the manner required by law. Proposals received will be opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 11:00 a.m. on April 6, 2021, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at its next meeting for action thereon.
