PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, S.W. MCKINLEY AVENUE AND S.W.
63RD STREET,
BETWEEN CONCRETE TECHNOLOGIES, INC. AND BELL AVENUE PROPERTIES

WHEREAS, on June 24, 2019 under Roll Call No. 19-0969, the City Council approved a private construction contract in the amount of \$443,030.50, between Concrete Technologies, Inc., Brad Baumler, President, 1001 SE 37th Street, Grimes, IA, 50111 - as Contractor, and Bell Avenue Properties, Thomas Koehn, President, 2601 Bell Avenue, Des Moines, IA, 50321 - as Owner, for construction of Paving Improvements described as paving improvements to serve the Waldinger Development located at the corner of S.W. McKinley Avenue and S.W. 63rd Street, as shown on Plan File Numbers 611-179/217, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
