WHEREAS, the Public Works Department requested the Finance Department Procurement Division to solicit bids for an annual contract with four (4) additional one year renewal options to furnish construction and aggregate materials; and

WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid J21-145 to eight (8) potential bidders with six (6) bids received; and

WHEREAS, the low dollar primary and secondary bids were determined on an item-by-item basis, with a haul rate of \$0.25/ton-mile from the supplier's plant or quarry applied to items to be picked up by City truck, at the prices shown on the attached bid tabulation form from the following companies:
