RATIFICATION OF THE NATIONAL PARK SERVICE (NPS) LAND AND WATER CONSERVATION FUND (LWCF) GRANT APPLICATION BY THE PARKS AND RECREATION DEPARTMENT SEEKING \$200,000 TOWARDS THE SW 1ST STREET BRIDGE IMPROVEMENT PROJECT.

WHEREAS, the City of Des Moines Parks and Recreation Department desires to develop the outdoor recreational facility on the SW 1st Street Bridge, located at 435 SW Water Street, Des Moines, for the enjoyment of the residents and visitors of Des Moines pursuant to the SW 1st Street Bridge Improvement project ("Project"), at a total pre-engineering estimated cost of \$750,000; and

WHEREAS, the Project includes resilient planting beds with low maintenance green roof vegetation to manage stormwater and provide visual interest, modular bench seating, a new shelter that will act as a rental unit for events, a dedicated multi-use trail corridor, hammock netted rest and relaxation areas, and sculptural play features suitable for multiple age groups; and

WHEREAS, the Parks and Recreation Department desires to seek a \$200,000 grant from the National Park Service (NPS) Land and Water Conservation Fund (LWCF) for financial assistance for the development of the Project, and, in order to meet such grant application deadline, submitted such application on March 15, 2021; and

WHEREAS, such grant application requires that the City Council provide certain authorizations and certifications when making application for such grant, as described below.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The above described Project is authorized.
2. The grant application submitted by the Parks and Recreation Department to the Iowa Department of Natural Resources to seek LWCF financial assistance from the NPS in the amount of 26.7% of the actual cost of the above described Project of \$750,000 is hereby ratified and the Department is authorized to have made such application on behalf of the City of Des Moines.

BE IT FURTHER RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City will accept the terms and conditions set forth in the NPS Grants-in Aid Manual and which will be a part of the Project Agreement for any grant awarded under the attached proposal/grant application ("proposal").
2. The City is in complete accord with the attached proposal and that it will carry out the development in the manner described in the proposal and any plans and specifications attached thereto unless prior approval for any change has been received from the Iowa Department of Natural Resources.
3. The City has the ability and intention to finance its share of the cost of the Project and that the Project will be operated and maintained at the City's expense for public outdoor recreational use.
4. No financial assistance has been given or promised under any other federal program or activity with regard to the proposed Project.

- 6. The City will maintain adequate financial records on the proposed Project to substantiate claims for cost-sharing.
