PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 2021 PCC RESIDENTIAL PAVING PROGRAM ; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS MPS ENGINEERS, P.C. DBA KINGSTON SERVICES, P.C., UMESH G. SHETYE, PRESIDENT, \$769,583.00

WHEREAS, on February 8, 2021, under Roll Call No. 21-0173, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2021 PCC Residential Paving Program , 062021004

The improvements include street reconstruction with twenty-seven (27) feet wide back-to-back Portland Cement Concrete (PCC) six (6) inches thick and integral curb, subbase, subdrain, subgrade treatment, grading, pavement removal, PCC driveways and sidewalk, storm sewer, retaining walls, traffic control, surface restoration, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 626-068/133, located at: Beckwith Avenue from 5th Avenue to 6th Avenue; 62nd Street from Grand Avenue to Walnut Hill Drive; Lincoln Place Drive from Mahaska Drive to 400 feet west, and driveway replacement at Fire Station No. 6 at 1919 SE 6th Street in Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, in accordance with said notice, those interested in said proposed plans, specifications, form of contract documents, and Engineer's estimate of construction cost both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the upon due consideration of the facts, and any and all statements of interested persons, any objections to the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement are overruled and the hearing is closed and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are here by approved.
