**ACCEPTANCE OF PROPOSAL WITH
MIDAMERICAN ENERGY COMPANY TO
INSTALL NEW LED STREETLIGHTS FOR THE
HUBBELL AVENUE RECONSTRUCTION FROM
E. EUCLID AVENUE TO EAST OF E. 38th STREET,
ESTIMATED AT \$177,956.30**

WHEREAS, reconstruction of Hubbell Avenue from E. Euclid Avenue to east of E. 38th Street requires installation of new streets lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install new galvanized poles with LED fixtures and underground wiring for Hubbell Avenue Reconstruction; and

WHEREAS, compensation will be based on actual costs, which costs are estimated at \$177,956.30.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting for Hubbell Avenue Reconstruction, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor is hereby authorized and directed to accept the proposal by signing it for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for actual costs upon receipt of an invoice acceptable to the Engineering Department.
