WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase of two (2) replacement truck chassis and specialized equipment bodies for use by the Department of Public Works; and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the equipment, which has been approved by the Fleet Oversight Committee (FOC) for a total amount of \$315,051.05, includes the following:

Two (2) conventional cab truck chassis from Housby Mack Inc., (4747 NE 14th Street, Des Moines, IA 50313, Kelly Housby, CEO), in the amount of \$170,050, utilizing Sourcewell Contract #060920-MAK.

One (1) material handling grapple loader from Mid-Iowa Solid Waste, in the amount of \$110,063.05, utilizing Sourcewell Contract # 041217-PAF.

One (1) forestry dump box body from Henderson Products Inc., (916 South 10th Street, Manchester, IA 52057, John Sievert, President), in the amount of \$34,938.00 utilizing Sourcewell Contract # 080818-HPI.

WHEREAS, funding in the amount of \$255,051.05 is available from 2021-2022 Operating Budget, Equipment Replacement Fund, page 83 and funding in the amount of \$60,000 is available from the IDOT VW Grant Settlement funding award.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of the above described two (2) replacement truck chassis and specialized equipment bodies for use by the Department of Public Works using utilizing multiple Sourcewell Purchasing Contracts, in the amount of \$315,051.05.
