WHEREAS, the Street Maintenance Division of the Public Works Department, along with the City of West Des Moines, Polk County and 26 other public entities representing the Central Iowa Salt Group (CISG) requested the solicitation of joint bids for rock salt for delivery to the Metropolitan Salt Storage Facility, and to individual CISG agencies storage facilities for the 2020-2021 snow and ice control season;

WHEREAS, the City of West Des Moines through its Public Works Department, on behalf of CISG, solicited invitation for bids by advertisement and mailing to five (5) potential bidders with three (3) bids received on April 22, 2020; and

WHEREAS, the low dollar compliant bids for the 2020-2021 snow and ice control season were received from Hutchinson Salt Co., 136 W. 12th Street, Baxter Springs, KS 66713, Larry Bingham, President, and

WHEREAS, the original Request for Bid document included a one (1) year term with the option to extend for an additional two (2) twelve month increments with an inflationary cost allowance; and

WHEREAS, Hutchinson Salt Co. has proposed a 1.2826% inflationary increase for the 2021 snow and ice control season, for a total pre-season delivery cost of \$60.92 per ton with Public Works will ordering 10,500 tons of salt for a total amount of \$639,660.

WHEREAS, Municipal Code section 2-726(m) authorizes the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, funding is available from PW240402/Street Maintenance for a total cost of \$639,660; and

WHEREAS, the Procurement Administrator and the Public Works Department recommend approval of the low dollar compliant bids;

NOW, THEREFORE, BE IT RESOLVED that the Des Moines City Council hereby accepts and approves a 1.2826% inflationary increase from Hutchinson Salt Co for the 2021 snow and ice control season, for a total pre-season delivery cost of \$60.92 per ton for a total amount of \$639,660.
