**ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY  
TO INSTALL STREET LIGHTING AND PEDESTRIAN LIGHTING FOR  
INGERSOLL AVENUE STREETScape  
FROM 24<sup>TH</sup> STREET TO 28<sup>TH</sup> STREET (NORTH SIDE),  
AT A COST OF \$103,791.44**

WHEREAS, construction of Ingersoll Avenue Streetscape from 24<sup>th</sup> Street to 28<sup>th</sup> Street (north side) requires installation of new streets lighting and pedestrian lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install eleven (11) new banner-strength, black street light poles with LED street lighting and pedestrian lighting for the Ingersoll Avenue Streetscape from 24<sup>th</sup> Street to 28<sup>th</sup> Street (north side); and

WHEREAS, the proposal provides that MidAmerican Energy Company's cost to install the streetlights is \$103,791.44.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting and pedestrian lighting for Ingersoll Avenue Streetscape from 24<sup>th</sup> Street to 28<sup>th</sup> Street (north side), a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor is hereby authorized and directed to accept the proposal for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for upon receipt of an invoice acceptable to the Engineering Department.
