STORM SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED
PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, RUBY ROSE RIDGE,
BETWEEN SPRING LAKE CONSTRUCTION, INC. AND KENYON HILL RIDGE, LLC

WHEREAS, on December 3, 2018 under Roll Call No. 18-1982, the City Council approved a private construction contract in the amount of \$240,700.00, between Spring Lake Construction, Inc., Dean Quirk, Owner, 4123 NW 95th Place, Polk City, IA, 50226 - as Contractor, and Kenyon Hill Ridge, LLC, Dean Quirk, Managing Partner, 33459 Berns Shore Drive, Adel, IA, 50003 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements to serve Ruby Rose Ridge development located at 5066 NE 23rd Avenue, as shown on Plan File Numbers 600-224/254, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
