**ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY  
TO REMOVE EXISTING UTILITY POLES AND  
RELOCATE OVERHEAD UTILITIES UNDERGROUND FOR  
E. 2<sup>ND</sup> STREET RECONSTRUCTION FROM  
E. COURT AVENUE TO IOWA INTERSTATE RAILROAD,  
IN AN ESTIMATED AMOUNT OF \$140,334.05**

WHEREAS, reconstruction of E. 2<sup>nd</sup> Street from E. Court Avenue to Iowa Interstate Railroad requires removal of existing utility poles and relocation of overhead utilities underground; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to remove the existing utility poles and relocate the overhead utilities underground; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to relocate the overhead utilities underground is \$140,334.05; and

WHEREAS, the proposal provides that since the estimated cost of construction is over \$100,000, the City is required by tariff to pay actual costs upon completion of the work, which could result in an additional charge or refund to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for removal of existing utility poles and relocation of overhead utilities underground for E. 2<sup>nd</sup> Street from E. Court Avenue to Iowa Interstate Railroad, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, and accepted.
2. That the Mayor is hereby authorized and directed to sign the proposal for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company upon receipt of an invoice acceptable to the Engineering Department.
