WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase a replacement compact tracked skid steer loader for use in the Parks and Recreation Department; and

WHEREAS, the equipment, which has been approved by the Fleet Oversight Committee (FOC), is being procured through the competitive bid process using State of Iowa contract MA 005-17312C; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts that have been competitively established through from supply schedules of the U.S. General Services Administration and from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, and the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, or pursuant to supply schedules of Polk County contracts or accepted bids pursuant to Polk County's bidding procedures, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the compact tracked skid steer loader is being purchased from Clark Equipment Company (d/b/a Bobcat Company, Government Sales), 250 East Beaton Drive, West Fargo, ND 58078, David Rowles, President, in the amount of \$60,709.30; and

WHEREAS, funding is available from the 2021-2022 Operating Budget, Equipment Replacement Fund, page 83.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of a replacement compact tracked skid steer loader for use in the Parks and Recreation Department from Clark Equipment Company (d/b/a Bobcat Company, Government Sales), in the amount of \$60,709.30 using State of Iowa contract MA 005-17312C.
