WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase one (1) additional hydraulic power unit with portable submersible pumps for use in the Sewers Division of the Department of Public Works; and

WHEREAS, the equipment, which has been approved by the Fleet Oversight Committee (FOC), is being procured through the competitive bid process using State of Iowa Contract 16201E; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts that have been competitively established through from supply schedules of the U.S. General Services Administration and from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, and the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, or pursuant to supply schedules of Polk County contracts or accepted bids pursuant to Polk County's bidding procedures, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the hydraulic power unit with portable submersible pumps is being purchased from Central Service and Supply, Dan Abramovich, President, 4219 East 50th Street, Des Moines, Iowa 50317 in the amount of \$65,310.00; and

WHEREAS, funding is available from the 2021-2022 Operating Budget, Equipment Replacement Fund, page 81.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of a one (1) additional hydraulic power unit with portable submersible pumps for use in the Sewers Division of the Department of Public Works from Central Service and Supply, in the amount of \$65,310.00 using State of Iowa Contract 16201E.
