APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, THREE LAKES ESTATES PLAT 7, BETWEEN LEGACY EXCAVATION, LLC AND J. LARSON HOMES, L.L.C.

WHEREAS, on May 4, 2020 under Roll Call No. 20-0740, the City Council approved a private construction contract in the amount of \$126,380.94, between Legacy Excavation, LLC, John Larson, Owner - as Contractor, and J. Larson Homes, L.L.C., John Larson, Managing Parter - as Owner, for construction of Paving Improvements described as paving improvements to serve Three Lakes Estates Plat 7, located north of E. Pine Avenue between Indianola Avenue and S.E. 36th Street, as shown on Plan File Numbers 611-259/279, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$126,380.94, which have been constructed in substantial compliance with the contract documents between Legacy Excavation, LLC and J. Larson Homes, L.L.C., which were approved under Roll Call No. 20-0740, dated May 4, 2020, be received and filed; and that completion of said Paving Improvements described as paving improvements to serve Three Lakes Estates Plat 7, located north of E. Pine Avenue between Indianola Avenue and S.E. 36th Street, as shown on Plan File Numbers 611-259/279, is hereby acknowledged and that said Paving Improvements are hereby accepted.
