RESOLUTION APPROVING THIRD AMENDMENT OF AGREEMENT BETWEEN CITY OF DES MOINES AND BEN SPELLMAN FOR PROPERTY LOCATED AT 1124 13TH STREET AND 1311 LAUREL STREET

WHEREAS, Iowa Code Section 446.19A permits cities to acquire tax sale certificates for abandoned property assessed as residential property or as commercial multifamily property or vacant residential lots at a tax sale without paying the taxes then due, to obtain the assignment of outstanding tax sale certificates by payment to the certificate holder the amount then due to redeem the certificate, and to further assign said certificates, all for the purpose of encouraging the acquisition and rehabilitation of abandoned dwellings and lots; and

WHEREAS, on February 5, 2018, by Roll Call No. 18-204, the City Council approved request to Polk County Board of Supervisors to assign tax sale certificates of purchase to the City, authorization for execution of Polk County Agreements, approval of City acquisition of properties through tax deed, authorization to request release of property taxes and special assessments, and release of all City liens and special assessments in order to encourage housing redevelopment at real property locally known as 1124 13th Street and 1311 Laurel Street (collectively "property"); and

WHEREAS, on January 14, 2019, by Roll Call 19-0076, the City Council approved sale and conveyance of said property to Indigo Dawn, LLC, which sale was for redevelopment of housing subject to the terms and conditions included in the Acquisition Agreement and Offer to Purchase between the parties; and

WHEREAS, on December 5, 2019, Indigo Dawn, LLC assigned its interest and obligations in the Acquisition Agreement to Astilbe Morning, LLC, ("Developer"), following approval of assignment by the City Community Development Director as authorized by the Acquisition Agreement; and

WHEREAS, on December 16, 2019, by Roll Call 19-2027, the City Council approved the First Amendment to Acquisition Agreement between the City of Des Moines and Astilbe Morning, LLC, to allow extension of the Agreement until December 30, 2020; and

WHEREAS, on November 9, 2020, by Roll Call 20-1781, the City Council approved the Second Amendment to Acquisition Agreement between the City of Des Moines and Astilbe Morning, LLC, to allow extension of the Agreement until December 30, 2021; and

WHEREAS, on July 01, 2021, Astilbe Morning, LLC assigned its interest and obligations in the Acquisition Agreement to Ben Spellman, ("Developer"), following approval of assignment by the City Neighborhood Services Director as authorized by the Acquisition Agreement; and

WHEREAS, the Developer has started rehabilitation process; and

WHEREAS, Ben Spellman has requested a Third amendment of the Acquisition Agreement extending the agreement to June 30, 2022 to allow completion of said redevelopment; and

THIRD AMENDMENT TO AGREEMENT BETWEEN CITY OF DES MOINES AND BEN SPELLMAN FOR ACQUISITION AND REHABILITATION/REDEVELOPMENT OF PROPERTIES LOCATED AT 1311 LAUREL AND 1124 13TH STREETS, DES MOINES, IOWA, FOR EXTENSION OF TIME FOR COMPLETION

WHEREAS, on January 14, 2019, by Roll Call 19-0076, the City Council approved the sale and conveyance of real property locally known as 1124 13th Street and 1311 Laurel Street (collectively "property" or "properties") to Indigo Dawn, L.L.C., which sale was for redevelopment of housing subject to the terms and conditions included in the Acquisition and Rehabilitation Agreement and Offer to Purchase between the parties; and

WHEREAS, on December 5, 2019, Indigo Dawn, L.L.C. assigned its interest and obligations in the Acquisition and Rehabilitation Agreement to Astilbe Morning, L.L.C., following approval of assignment by the City Community Development Director as authorized by the Acquisition and Rehabilitation Agreement; and

WHEREAS, on December 16, 2019, by Roll Call 19-2027, the City Council approved the First Amendment to Acquisition and Rehabilitation Agreement between the City of Des Moines and Astilbe Morning, LLC, to allow extension of the Agreement until December 30, 2020; and

WHEREAS, on November 9, 2020, by Roll Call 20-1781, the City Council approved the Second Amendment of Agreement between the City of Des Moines and Astilbe Morning, LLC, to allow extension of the Agreement until December 31, 2021; and

WHEREAS, on July 01, 2021, Astilbe Morning, L.L.C. assigned its interest and obligations in the Acquisition and Rehabilitation Agreement to Ben Spellman, following approval of assignment by the City Neighborhood Services Director as authorized by the Acquisition and Rehabilitation Agreement; and

WHEREAS, Ben Spellman ("Developer") has requested the Third amendment of the Acquisition Agreement extending the agreement to June 30, 2022 to allow completion of redevelopment of single family home on the site; and

WHEREAS City and Developer have negotiated the following amendments to said Acquisition Agreement,

NOW THEREFORE, it is mutually agreed by the City and Developer as follows:

- 1. That the Acquisition Agreement is hereby amended in accordance with the terms set forth in this Amendment.
- 2. All other terms, provisions, and conditions originally set forth in the Acquisition Agreement remain effective and binding upon the City and Developer.


