WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase of twenty (20) replacement and three (3) additional vehicles for the fleet by use in various City Departments; and

WHEREAS, Twelve (12) vehicles including; Nine (9) one quarter ton compact pickup trucks and three (3) compact SUVs are being procured through the competitive bid process using the State of Iowa (DAS) purchasing contract number MA21150; and

WHEREAS, Eleven (11) vehicles including; four (4) half ton special service vehicle pickup trucks, three (3) one ton pickup trucks, two (2) three quarter ton pickup trucks, two (2) minivans are being procured through the competitive bid process using the State of Iowa (DAS) purchasing contract numbers MA22080 and MA21146; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, Twelve (12) vehicles including; Nine (9) one quarter ton compact pickup trucks and three (3) compact SUVs are being purchased from Dewey Ford (3055 SW Delaware, Ankeny, Iowa 50021, Dan Boettcher, General Manager), in the amount of \$322,214.40 utilizing the State of Iowa (DAS) purchasing contract number MA21150; and

WHEREAS, Eleven (11) vehicles including; four (4) half ton special service vehicle pickup trucks, three (3) one ton pickup trucks, two (2) three quarter ton pickup trucks, two (2) minivans are being purchased from Stew Hansen Dodge City (12103 Hickman Road, Des Moines, IA 50323, Dan Boettcher, General Manager), in the amount of \$400,780.00 utilizing the State of Iowa (DAS) purchasing contract numbers MA22080 and MA21146; and

WHEREAS, funding is available from 2021-2022 Operating Budget, page 81, I201 Equipment Replacement for a total amount of \$722,994.40.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of twenty (20) replacement and three (3) additional vehicles for the fleet by use in various City Departments from Dewey Ford and Stew Hansen Dodge City in the total amount of \$722,994.40 using the State of Iowa (DAS) purchasing contract numbers MA21150, MA22080 and MA21146.
