RESOLUTION AMENDING COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROJECT AGREEMENT WITH 6TH AVENUE CORRIDOR INC. (6AC) FOR REDEVELOPMENT PROJECT AT 1601 6TH AVENUE

WHEREAS, on October 24, 2016 by Roll Call No. 16-1829, 6th Avenue Corridor Inc. (6AC) entered an agreement to acquire the property at 1601 6th Avenue and utilize Community Development Block Grant (CDBG) funding to assist with the rehabilitation of the building also known as the former North Des Moines City Hall; and

WHEREAS, projects that utilize Community Development Block Grant (CDBG) funding to create dwelling units must reserve at least fifty one percent (51%) of those units for low-and-moderate-income persons; and

WHEREAS, 6th Avenue Corridor Inc. (6AC) agreed to a restrictive covenant that requires a rent limit equal to sixty five percent (65%) of the most recent HOME Investment Partnership (HOME) rent limit; and

WHEREAS, confusion with the rent limit in the restrictive covenant has grown because HOME Investment Partnership (HOME) funds are not utilized for the project at 1601 6th Avenue; and

WHEREAS, market research and financial analysis conducted by 6th Avenue Corridor Inc. (6AC) indicates an \$850 rent limit is fair and affordable for dwelling units reserved for low-and-moderate-income persons; and

WHEREAS, in an attempt to preserve historical accuracy and qualify for funding from other sources, 6th Avenue Corridor (6AC) desires to decrease the total number of dwelling units to three (3), of which two (2) will be affordable; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Des Moines, Iowa, that:

- 1. City staff are approved to amend the restrictive covenant with 6th Avenue Corridor Inc. (6AC) at 1601 6th Avenue to set a rent limit for affordable dwelling units at \$850 and reduce the total number of units created from six (6) to three (3), of which two (2) will be affordable.
- 2. The Neighborhood Services Director is hereby authorized to execute, on behalf of the City, an amendment to the restrictive covenant with 6th Avenue Corridor Inc. (6AC) at 1601 6th Avenue to set a rent limit for affordable housing units at \$850 and reduce the total number of units created from six (6) to three (3), of which two (2) will be affordable.
