PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, 401 S.E. 6TH STREET,
BETWEEN CORELL CONTRACTOR, INC. AND CONNOLLY LOFTS ASSOCIATES, L.P.

WHEREAS, on December 21, 2020 under Roll Call No. 20-2089, the City Council approved a private construction contract in the amount of \$72,752.00, between Corell Contractor, Inc., Grant S. Corell, President, 1300 Lincoln Street, West Des Moines, IA, 50265 - as Contractor, and Connolly Lofts Associates, L.P., Frank Levy, President, 3408 Woodland Avenue, West Des Moines, IA, 50266 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements to serve Connolly Lofts located at 401 S.E. 6th Street, as shown on Plan File numbers 591-048/049, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
