RE: City Engineer's Certification Emergency Repairs Required City Manager's Finding of Necessity to Institute Emergency Proceedings Nahas Pool Painting Improvements Activity ID 11-2021-010

Extensive paint spalling and surface defects were discovered at the Nahas swimming pool. Based upon the investigation by City staff and my review of the investigation, I recommend that emergency repairs be contracted immediately. The repairs and painting need to be completed prior to opening the swimming pool to the public. If these emergency repairs are not done in a timely manner, the swimming pool will not be able to be open to the public this year. If the pool is opened the chipped paint and surface deficiencies have created very sharp edges along the edge and walls of the pool putting the patrons at risk. These sharp edges will most likely cut the swimming pool patrons causing harm and possibly infecting other patrons with blood born pathogens.

As City Engineer, being a licensed professional engineer in the State of Iowa, I hereby certify that emergency repairs are necessary as described above for the Nahas Pool Painting Improvements project as the delay of advertising and public letting might cause serious loss or injury to the City. I hereby request that the City Manager make a finding to institute emergency proceedings under Section 384.103(2) of the Iowa Code and to proceed with the necessary actions to proceed with a change order with A1A Sandblasting (Iowa) for additional work on the Ashworth Pool and Northwest Pool Painting Improvements public improvement project for these emergency repairs without holding a public hearing and advertising for bids.

I concur with the City Engineer's certification that emergency repairs are necessary, as described above, as the delay of advertising and public letting might cause serious loss or injury to the City. I hereby make a finding of the necessity to institute emergency proceedings for the Nahas Pool Painting Improvements project under Section 384.103(2) of the Iowa Code and direct the Engineering Department to proceed with the necessary actions to enter into a contract for execution by the City Manager for these emergency repairs without holding a public hearing and advertising for bids.
