**ACCEPTANCE OF PROPOSAL FROM
MIDAMERICAN ENERGY COMPANY TO
INSTALL NEW LED STREETLIGHTS FOR
INDIANOLA AVENUE RECONSTRUCTION FROM
E. ARMY POST ROAD TO U.S. HIGHWAY 69,
ESTIMATED AT \$84,680.80**

WHEREAS, reconstruction of Indianola Avenue from E. Army Post Road to U.S. Highway 69 requires installation of new streets lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install wood, black direct embed, and galvanized poles with LED fixtures for Indianola Avenue Reconstruction; and

WHEREAS, compensation will be based on actual costs, which costs are estimated at \$84,680.80.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting for Indianola Avenue Reconstruction, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor is hereby authorized and directed to accept the proposal by signing it for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for actual costs upon receipt of an invoice acceptable to the Engineering Department.

Enclosed is our streetlight proposal for Indianola Avenue; WMIS: 2838305, 2941053

This proposal includes the installation of streetlights on:

**Army Post Road, Bloomfield Road, E County Line Road, Indianola
Ave, E Pine Ave & Hwy 69**

We Propose To:

Install:	3	150W	LED streetlights on 30' wood poles
Install:	38	250W	LED streetlights on 30' wood poles
Install:	4	250W	LED streetlights on 34.5' black direct embed poles
Install:	2	250W	LED streetlights on galvanized break-away poles
Install:	1	250W	LED streetlights on 35' wood pole with 6' mast
Install:	1	250W	LED streetlights on 35' direct embed galvanized pole
Install:	1	150W	LED streetlights on 35' steel pole with 15' mast and breakaway base with screw anchor

The cost for the installation of these lights is **\$84,680.80** and will be billed to the City upon completion of our work.

Some of these lights will be installed on steel poles and served by underground conductors, but all the lights will be billed to the City at the wood pole, overhead rate because the City has agreed to pay the streetlight facilities charge.

MidAmerican Energy Company's streetlight proposal is based on the approved street light analysis provided by the City. MidAmerican Energy Company will install the lights based on the staked locations provided in the field by the City
