APPROVE PROCUREMENT OF SaaS SOFTWARE APPLICATIONS PROVIDING ELECTRONIC RECORDS MANAGEMENT FOR CITY OF DES MOINES FIRE DEPARTMENT

WHEREAS, September 1, 2018, the City of Des Moines Fire Department entered into a Master Subscription and License Agreement (MSLA) with ESO Solutions (9020 N Capital of Texas Hwy, Austin, TX 78759; Chris Dillie, President) for the provision of SaaS software applications providing for electronic records management; and

WHEREAS, constraints regarding personnel time required for implementation of all applications available within the software schedule of the Agreement have prohibited the Fire Department from procuring the complete suite of record management software provided for in the MSLA between the City of Des Moines and ESO Solutions; and

WHEREAS, the Fire Department has budgeted FY22 funds and personnel availability for the procurement and implementation of additional SaaS software applications for the enhancement of the Department's electronic records management system and increase of the Department's ability to comply with FEMA's National Fire Incident Reporting System (NFIRS) reporting requirements; and

WHEREAS, the Fire Department has determined that such SaaS applications are included in the Software Schedule of the current Master Subscription and License Agreement (MSLA) between the City of Des Moines and ESO Solutions established September 1, 2018; and

WHEREAS, the procurement of additional SaaS software applications under the Master Subscription and License Agreement (MSLA), including ESO Fire Records Management System, Vehicle Asset Management applications, and NFIRS reporting data import from ESO Solutions will be a one-time cost of \$62,081.60; and

WHEREAS, funding is available from FD010200, technical services.

NOW, THEREFORE, BE IT RESOLVED that the Des Moines City Council hereby accepts and approves the above described purchase of the additional SaaS software applications under the existing Master Subscription and License Agreement (MSLA) between the City of Des Moines and ESO Solutions for an amount of \$62,081.60.
