**RESOLUTION DISMISSING HEARING ON APPROVAL OF PLANS,  
SPECIFICATIONS, FORM OF CONTRACT, AND ENGINEER'S ESTIMATE  
ON THE CITY-WIDE SKYWALK JOINT SEAL REPLACEMENTS DUE TO  
NO BIDS BEING RECEIVED**

WHEREAS, on March 21, 2022, under Roll Call No. 22-0390, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

City-wide Skywalk Joint Seal Replacements, Activity ID 042022005

The improvement includes the repair and replacement of skywalk bridge joint seals; all in accordance with the contract documents, including Plan File No. 636-001/016, located at skywalk bridges 4E-4F, 5Da, 5E-5F, 6DaE, 6DaW, 7C-8C, 7D-8D, 8DaE, 7F-8F, 8C-8D, 8C-9C, 8E-9E, 8F-9F, 5C-5D (Add Alternate #1), and 5D-6D (Add Alternate #2), in Des Moines, Iowa.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law; and

WHEREAS, a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa was held at 11:00 a.m. on April 19, 2022 to receive and open bids for said improvement; and

WHEREAS, no bids were received for said improvement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa: That due to no bids being received for the above referenced improvement, this hearing is hereby dismissed.
