**ACCEPTANCE OF PROPOSAL FROM
MIDAMERICAN ENERGY COMPANY TO
INSTALL NEW LED STREETLIGHTS FOR
6th AVENUE STREETScape – COLLEGE AVENUE TO UNIVERSITY AVENUE,
ESTIMATED AT \$148,958.96**

WHEREAS, 6th Avenue Streetscape – College Avenue to University Avenue requires installation of new streets lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install 13 black galvanized steel banner street poles with LED fixtures for 6th Avenue Streetscape – College Avenue to University Avenue; and

WHEREAS, compensation will be based on actual costs, which costs are estimated at \$148,958.96.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting for 6th Avenue Streetscape – College Avenue to University Avenue, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor is hereby authorized and directed to accept the proposal by signing it for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for actual costs upon receipt of an invoice acceptable to the Engineering Department.
