**PURCHASE OF ELECTRIC REPLACEMENT REFUSE TRUCK**

WHEREAS, the Department of Finance, Procurement Division was requested to issue a purchase order for the purchase of One (1) Electric Replacement Refuse Truck Chassis with a specified collection equipment body for use by the Department of Public Works; and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, One (1) Electric Truck Chassis is provided by Housby Mack Inc., (4747 NE 14th Street, Des Moines, IA 50313, Kelly Housby, President), in the amount of \$428,219.00, utilizing Sourcewell purchasing contract number 060920-MAK; and

WHEREAS, One (1) Electrically Powered Automated Side Loading Refuse Collection Equipment Body for the above referenced truck chassis is provided by McNeilus Truck and Manufacturing, (520 Highway, Suite E, Dodge Center, MN 55927, Brad Nelson, President), in the amount of \$276,337.00 utilizing Sourcewell purchasing contract number 091219-MCN; and

WHEREAS, funding is available from 2022-2023 Operating Budget, page 80, I201, Equipment Replacement in the total amount of \$704,556.00.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of One (1) Electric Replacement Refuse Truck Chassis with a specified collection equipment body from Housby Mack Inc. and McNeilus Truck and Manufacturing in the total amount of \$704,556.00 using the Sourcewell purchasing contract numbers 060920-MAK and 091219-MCN. The Finance Department is hereby directed to proceed with negotiation of any agreements or amendments deemed necessary to the existing master agreement 091219-MCN between the Sourcewell and McNeilus Truck and Manufacturing.
