RESOLUTION APPROVING THE PURCHASE OF HIGH-STRENGTH GROUT PRODUCTS FOR SEWER MANHOLE REHABILITATION FROM AP/M PERMAFORM AT AN ANNUAL ESTIMATED AMOUNT OF \$100,000.00

WHEREAS, the Public Works Department, Sewers Division requested the Finance Department, Procurement Division to issue a blanket purchase order for high-strength grout products, for use with previously purchased sewer manhole rehabilitation equipment, to be purchased during fiscal year 2023; and

WHEREAS, the Procurement Administrator has determined that said high-strength grout products are available from AP/M Permaform, Bill Shook, President, PO Box 555, Johnston, IA 50131-0555, the sole area-wide distributor until equipment warranty has expired; and

WHEREAS, Des Moines Municipal Code Section 2-726(d) provides for the non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing City needs, materials or equipment to be cost-effective, as found and declared in writing by the Procurement Administrator and filed with the procurement documents; and

WHEREAS, funding is available from PW247461/532050, FY2022-2023 Public Works Operating Budget.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the purchase of high-strength grout products during the fiscal year 2023 from AP/M Permaform, at a total estimated annual cost of \$100,000.00, is hereby accepted and approved pursuant to blanket purchase order issued by the Finance Department, Procurement Division.
